To consider request dated 02.01.2020 received from Research Officer in Charge, Clinical Research Unit in the campus of Cantt General Hospital, Meerut Cantt for renewal of MoU w.e.f. 19.03.2020.

Board is informed that accommodation was provided under the authority of the Board vide CBR No. 319 dated 30.11.2012 and subsequent MoU approved by board vide CBR No. 365 dated 25.02.2013 to the Clinical Research Unit for research in Unani medicines (AYUSH), an organization under the Ministry of Health & Family Welfare, Govt. of India on the request made by the Director General, Central Counsel for Research in Unani Medicines, Ministry of Health & Family Welfare, New Delhi for running their Unani unit in the campus of Cantonment General Hospital at a normal fee and distribution of free medicines to the patient provided by the Govt. of India, Ministry of Health & Family Welfare.

As per clause 10 of the agreement dated 18.07.2019 the agreement is valid for a period of 01 year w.e.f. 19.03.2019 to 18.03.2020. However, the agreement may be renewed for a further period of one year on mutual agreement of both the parties. The agreement in question has expired on 18.03.2020.

Board is further informed that the unit is running satisfactorily and patients visits in the unit is highest as compared to other departments of the hospital.

Relevant file is put up on the table.

Board may consider & take suitable decision in the matter.

# 8. **RESOLUTION**

Considered and resolved that agreement for the clinical research unit be extended for further period of one year. i.e. 19-03-2020 to 18-03-2021.

However, it is suggested by Brig. G.S Nagi that name of Clinical Research Unit be changed as Unani Dispansary because there is no research in the Unit. Hence, name of the Unit may be changed in the agreement. Board agreed for the same.

### 9. **RENEWAL OF CONTRACTUAL ENGAGEMENT OF HOSPITAL STAFF.**

Shri Anil Jain, Member informed to the board that during surprise inspection by few members doctors were not found on duty. Services provided by them are not up to the mark and therefore their services are no more required as such it's a wastage of finances.

A Note given by Smt. Manju Goel is reproduced below.

Considered and resolved that contractual agreement of GDMO and Homeopathic Consultant be discontinued and there is no need of renewal.

Strong objection on the agenda item, Hospital is totally closed, it is wasteful expenditure. No public is getting any benefit of the Cantt General Hospital Services, therefore contractual engagement be

discontinued with immediate effect. Meanwhile, all details regarding OPD and Indoor patients and their treatments be called upon from the CGH and be placed in the next Board.

# 10. WILLINGNESS TO EXECUTE THE WORK OF DOOR TO DOOR GARBAGE COLLECTION

Ref. : CBR No. 293 dated 14.01.2020.

Vide above CBR it was resolved that the contract for door to door garbage collection @ Rs.18.57 a) Lakh per month approved vide CBR No. 212 dated 27.09.2019 needs to reviewed the contract agreement for the same has also not been executed. PCB asked why the contract rates have increased to Rs.18.57 lakh per month compared to Rs.15.60 lakh as was earlier. CEO informed that the rate of Rs.15.60 lakh per month was of 2016-17 and as per present tender few items like battery operated vehicles have been incorporated instead of cycle rickshaws. CEO further opined that as financial condition of the board is very bad such door to door collection of garbage by the contracting agency be hold for some time and the work be executed departmentally as such board can review its decision after 3 months. PCB asked the views of the Members. Shri Vipin Sodhi, Vice President was of the view that last year Cantt Board stood at 2<sup>nd</sup> position in Swachchta Sarvekshan 2019 and execution of work of door to door garbage collection departmentally will not suffice the standard for the same this year. He suggested that concerned contractor be issued a notice first whether he is willing to reduce his rates @ Rs.15.60 Lakh per month to avoid future litigation as e-tenders were invited for the same and Board had approved the lowest tender and there -after the matter be put up before the Board for decision. Smt. Rini Jain, Shri Neeraj Rathore, Shri Anil Jain & Shri Dharmendra Sonkar agreed with the views of Vice President. Shri. Anil Jain further informed to the board that when the door to door collection started in the cantonment on experimental basis collection was done in few wards by department whereas in few wards it was by outsourcing. After review it was found that the outsourcing model was better and accepted. Therefore same be continued. Smt. Beena Wadhwa & Smt. Manju Goel Members left it to the Board to decide.

Board thereafter by majority of votes resolved that the work be carried out by outsourcing agency and the agency be issued notice to appear before the board to ascertain whether it is ready to carry out the work at old rates i.e. Rs.15.60 lakh per month till then the existing system of door to door garbage collection and lifting from dustbin points to Trenching Ground @ Rs.15.60 Lakh per month as approved by the Board vide CBR No.212 dated 27.09.2019 will continue.

b) A notice/letter No. 87/C/260 dated 16.03.2020 was issued to the Agency M/s Agarwal & Co. to appear before the Board and his consent. One more notice dated 31.03.2020 was also issued for the same. The agency replied that after Lockdown caused by COVID-19 they will be present in front for further discussion on Rates and to execute an agreement in this regard after lockdown.

c) As a present financial condition of the Board is very bad. The agency has not been paid the monthly installment upto Dec'2019. It is advised that in view of poor financial conditions the services be discontinued as it will lead to heavy liabilities. The complete file alongwith all documents is placed on the table.

d) The matter is put up before the Board to discuss with agency.

# 10. **RESOLUTION**

CEO at the beginning of the discussion brought the point to the notice of the board that there were certain directions from the G O C in C about fiscal discipline and board should take the decision accordingly.

Shri. NeeraJ Rathore was of opinion that the door to door collection is started as per the directions and guidelines of GoI and therefore the services can not be discontinued. All members thereafter agreed to continue the practice of door to door collection.

Col. Sandeep Satwalekar raised a valid point that when the board has not paid to the contractor for five months how can the amount be raised. Shri. Dharmendra Sonkar member was of opinion that the board gets some amount under Swatchata Action Plan in Swatchata Fund and same may be spent exclusively for the purpose of door to door garbage collection.

Board thereafter agreed that the same practice may be continued.

Shri Anil Jain member was of opinion that if the contractor who is providing the services at present agrees to extend its services at existing rates and terms and conditions, the contract may be extended.

PCB asked whether the services can be provided at cheaper rates by the department by hiring manpower. While clarifying it, member secretary brought the fact to the notice of the board that twice the report is obtained from the SS and SIs and as per their reports the amount is almost same as is being spent on contractual services. The reports of SS and SIs is pasted as below:

Board thereafter resolved that if the amount required for the services is same and existing contractor agrees to provide the services on existing rates and terms and conditions, same may be continued. Board also noted the fact that as same contractor/agency had quoted the rate of Rs 18.57 lakhs per month in a revised tender therefore by extending the contract on existing rates and terms and conditions the board

will save Rs 3 lakh per month and therefore it may be extended on existing rates i.e.Rs15.60 lakh per month.

All members agreed to continue the Agreement on existing rates and on same terms and conditions of the contract. Contractor was called before the Board for his consent. The contractor agreed to provide the services @ rate i.e. Rs. 15.60 lakh per month. The contractor was required to submit his consent as written statement which is reproduced below:

It is also agreed and resolved by the board that a clause of termination of contract on one months notice without assigning any reasons may be incorporated in the contract aggreement.

Door to Door Collection of garbage is necessary in the welfare of general public but the cost of the service provided to the public be recovered adopting expedited measures as the cost of service is very reasonable and minimum fixed by the Board but the Board is not aware WHY door to door collection charges are not being recovered, detailed report regarding Total DEMAND and Total RECOVERY during last 3 years made by the office be circulated to all the members with in a period of 07 days from this meeting and the services be continued till the lockdown caused by COVID-19 on the prevailing rates, terms and condition approved by the Board vide C.B.R. No 212 Dated 27.09.2019 or on rates approved by the Board in today meeting, as door to door service being an amenity which cannot be stopped now.

Further, It is also suggested that instead of issuing many bills for recovery from a House Owner, A consolidated bill for recovery under different HEADS viz House Tax, Water Tax, Door to Door Collection Charges, Water Charges and Sanitary Cess etc. should be given which will be very effective for recovery, it will also lead to expedite recovery. The same pattern is being followed in the Cantt Board Pune and

others. Accordingly SOFTWARE may be modified for generation of bill and segregation of amount recovered under various heads.

### 11. VEHICLE ENTRY FEE WITHIN THE LIMITS OF MEERUT CANTONMENT.

Board is informed that the contract for grant of license for collection of Vehicle entry fee u/s 67(e) of Cantonment Act 2006 from 11 entry points within the limits of Meerut Cantonment on commercial vehicles laden with goods or passengers entering/passing through Meerut Cantonment for a period of one year w.e.f. 08.12.2019 at 000 hours to 07.12.2020 at 2400 hours was given to Smt Anita Singh, R/o B-84, European Estate, Kanker Khera, Bye pass road, Meerut vide CBR No. 227 dated 13.11.2019.

The matter of vehicle entry fee was again considered in the Board meeting held on 12.12.2019 and three entry Points viz. Delhi Road, Mawana Road & Roorkee Road were kept hold in abeyance for two months vide CBR No. 285 dated 12.12.2019. With the said order of 03 points , Smt. Anita Singh filed a writ petition No. 42817 of 2019 , Smt Anita Singh V/s UOI & 02 others in the Hon'ble High Court, Allahabad. The Hon'ble High Court, Allahabad passed an order on 20.12.2019 and stayed the operation of order dated 12.12.2019. An another writ petition No. 2168 of 2020 wa also filed by the contractor in the Honble High court, Allahabad and the same was disposed off on March 2020. Thereafter, the contractor started depositing the daily amount of Rs 421750/- + allied charges in the office of Cantt Board, Meerut.

Board further informed that the contractor vide application dated 12.02.2020 & 13.02.2020 has requested that:-

- 1. That the collection of vehicle entry point at Delhi road at one side has not been started by her due to insufficient space/widening of road since the commencement of the contract & therefore to reduce her daily installment accordingly.
- 2. That during the stoppage of collection of vehicle entry fee from said 03 points, an expenditure of Rs 33,63,681.00 +5,00,000.00 (Court expenses) = 38,63,681.00 was incurred by her and the same may be adjusted in daily installment.
- 3. That an expenditure of Rs 22,57,950/- was incurred by her for widening of road, toilets, staff room, electric arrangements, water arrangements, trollies etc at vehicle entry points within the limit of Meerut Cantonment.

Thereafter, the office forwarded a letter dated 14.02.2020 to Sh S.K. Rai, (advocate) Standing counsel High Court at Allahabad regarding for non collection of Vehicle entry fee from one side at Delhi road (near B.No 197) and adjustment in daily installment as also on the matter regarding expenditure incurred by her during stoppage of collection of Vehicle entry fee from the said 03 points as per contract agreement.

Sh. SK Rai, Advocate, High Court, Allahabad vide letter dated 23.02.2020 has opined that "the contractor is a private contract and contractor is supposed to collect the money and deposit it, how is she suffered loss, is not clear nor she has filed any suit for damages. In the meantime, the contractor after negotitation, agreed to pay and paid accordingly amount @rs. 1,250000/- and other charges during the holding of collection at 03 points and the receipt of the H.C order by the office. There is an arbitration clause, "Clause-27" in with reference to any dispute and/or difference arising between the parties out of this contract shall be settled by Arbitration.

With regard to collection at Delhi road no such type of problem as mentioned in your letter was brought to the notice of the court by the contractor. The Hon'ble High Court vide its order dated 20.12.2019 stayed the effect and operation of the communication order dated 12.12.2019 of the C.E.O until further orders. Therefore, status quo is being maintained as on that day by the Court.

In view of the above, it is my considered opinion that the board may decide the matter taking into cognizance of the interim, order passed by the Hon'ble High Court and statement made before the Court, so that no further any king of non-compliance may be occurred or observed by the Hon'ble High Court, as the matter is still subjudice before the Hon'ble High Court and the interim order of status qup is operating too".

In the meantime, while collecting vehicle entry fee, the contractor deposited the daily amount of Rs 421750/- + allied charges upto 21.03.2020.

#### After lockdown due to coronavirus (pandemic)

Board further informed that due to outbreak of coronavirus pandemic, the Govt of India imposed Janta curfew on 22.03.2020 and lock down the country for three weeks w.e.f 23.03.2020 to 14.04.2020 and further extended lockdown to 31.05.2020 respectively. Meanwhile, the NHAI taken the resemption of traffric w.e.f 25.04.2020 under the provision of lock dowdown. Thereafter, an application was moved by contractor on 29.04.2020 & 30.04.2020 for resuming the collection of Vehicle entry fee. The office vide letter dated 04.05.2020 informed the contractor to obey the order passed in writ petion 42817 of 2019 and deposit the amount accordingly by following preventive measures in terms of guidelines issued by the government of India or COVID-19.

The contractor re-started the collection of vehicle etnry fee w.e.f 06.05.2020 at 07.00 AM from all VEF points and started depositing self-assed amount of Rs. 50,000/- per day in the official account of Cantt Board Meerut in P.N.B Bombay Bazar Meerut instead of depositing Rs. 4,21,750/ + allied charges per day as per the orders of Hon'ble High Court Allahabad mentioned above.

Further, the office conducted the survey at all points w.e.f 11.05.2020 at 08.PM to 14.05.2020 at 08.00 PM for three days. The details are as under :-

At present, the survey of all vehicle entry points is going on by the Cantt Board staff . The contractor again vide application dated 15.05.2020 and 16.05.2020 submitted the expenditure borne by her collection @ Rs 43500/- per day and requested to adjust from the collection per day. The survery of all points mentioned above is put up before the Board.

Relevant file is put up on the table.

Board is requested to consider and decide further.

#### 11. **RESOLUTION**

At the beginning of the discussion on the point member secretary clarified that there are certain developments before lockdown and certain after lockdown. He clarified that in the month of February the contractor submitted an application requesting

- a. Waiver of Rs. 1,35,000/- as collection at one point on Delhi road was not started.
- b. Compensation for the loss amounting to Rs. 38,00,000 when the collection was stopped by the board on Delhi road, Roorkie Road and Mawana road.
- c. As per terms and conditions of the contract the expenditure for infrastructure development at certain points be compensated.

Member Secretary thereafter informed that the contractor didn't deposit the daily installment since  $22^{nd}$  March till 6<sup>th</sup> May.

On 6<sup>th</sup> May the contractor started the collection afresh and deposited Rs. 50,000/- per day till date. He is transferring the money in the accounts though RTGS. CEO further clarified that in the garb of stay order contractor is taking decision unilaterally and started depositing only Rs. 50,000/-and therefore in order to ascertain the facts as to how the situation on ground is and how many vehicles are actually plying on the roads, staff was deployed and it was found that actual collection is more than the amount deposited by the contractor.

Smt Manju Goel raised objection about the survey of vehicles by staff. However, she couldn't give better solution when there is stay order, dates of court case not known as court is not functioning, what will be the outcome contractor started depositing only Rs. 50,000/- and had staff not deployed exact figure would not have known.

PCB thereafter put the matter for the discussion of the board.

While considering the waiver of Rs 1,35,000/- and compensation of loss when collection was hold at three points, PCB and VP asked actual figures. Member secretary clarified that

- a. The contractor has submitted confusing reports about the engagement of manpower. At the beginning of the contract he had submitted a list of 71 employees with their credentials and same should be taken as a base while calculating the expenditure on manpower.
- b. All 11 points had been handed over to the contractor and contractor has taken over all.
- c. After Hon'ble H.C. decision in case no. 42817 of 2019 dated 20.12.2019, the contarctor started depositing the installment as per agreement and the actual amount of collection as has been informed by the contractor was always more than the amount of installment.
- 1. Based on the above facts the board resolved that loss of collection can not be considered as such as per Hon'ble H.C. order the contractor is supposed to pay entire installment as has been paid in the initial days of the contract and after the Hon'ble H.C. order dated .
- 2. While discussing the amount of loss when the collection at 3 points was hold in abeyance shri. Vipin Sodhi asked the details. CEO clarified that the contractor has claimed amount spent on manpower, legal expenses and profit on the collection. Elected members were of opinion that the amount on manpower may be considered and not other claims viz. profit and legal expenses. Shri. Vipin Sodhi asked the revenue section about exact amount calculated on manpower. Revenue section clarified that as per calculation it comes near about Rs. 8,91,265/- At this point Col. Sandeep Satwalekar raised a valid point that when the case is still subjudice and final decision is yet to come can the board decide the matter. At this point PCB opined that legal advice be obtained on these points. Board therefore resolved to pend the matter.
- 3. While deciding the expences incurred on the infrastructure, CEO clarified that Rs. 22,57,950/- is claimed by the contractor and Rs. 20,91,208/- is calculated by the engineering section. As per

the Revenue section the expenditure for Boundry road is not included in the contract and should not be paid. Board thereafter resolved that Rs. 18,56,424/- only be adjusted as per clause no. 15(a) of the contract agreement.

Board thereafter deliberated on the developments from 22<sup>nd</sup> March till date and the amount deposited by the contractor.CEO clarified that the contractor was asked to deposit entire amount for the said period. PCB and SEMO were of opinion that the contractor should have deposited entire amount as per the contract agreement. Few members were of opinion that as there was complete lockdown and vehicles were not plying on the road as per order of GoI therefore for said period amount may be fixed after discussing the matter with the contracting agency before taking any decision unilaterally. Board thereafter resolved to discuss the matter with the contractor who was present.

Authorized representative Shri Vaibhav & Shri K.P. Singh attended meeting on behalf of Smt. Anita Singh. It was clarified that on 22<sup>nd</sup> March there was janta Curfew, immediately UP government announced lockdown followed by GoI announcing it on 25th of March and therefore there was no collection till the relaxation given by the Govt for vehicles on National highway. Thereafter the agency started the collection from 6<sup>th</sup> May. At present few vehicles are plying and he had to pay to his employees as well. The Govt has issued the directions for a ' Force Majure' clause for Goods, Services and Transportation affected during this period. As goods and services were adversaly affected the transportation carrying them is also adversely affected and therefore the amount to be deposited may be decided after negotiation. It was further clarified that for toll collection points on National Highways government has issued direction to have government representative at such points to assess the number of vehicles plying during this period. At Bareilly cantonment such arrangement has been made. Board asked the contractor to produce copy of National Highway order for assessment of the collection and vehicular movement. He also clarified that at few cantonments viz Pune, Roorkee, Lucknow the collection has yet not started whereas he had started the work from 6<sup>th</sup> May which will benefit both the Cantonment as well as his agency. Cantonment will get some revenue and he would meet the expenditure and pay to his employees and therefore amount may be decided by negotiation. Board thereafter resolved that considering the expenditure the contractor should pay @ Rs. 1 lakh per day for a period from 6<sup>th</sup> May till 31<sup>st</sup> May. Contractor clarified that only 20% vehicles are now on the road and he would not be able to pay that much amount. Board brought the fact to his notice that collection was as high as 1,32,000/- on one occasion. Thereafter it was agreed by agency to pay an amount @ Rs. 90000/-+ allied charges per day for this period. The consent given by the contractor is appended as below:

Board thereafter resolved as follows:

- 1. Contractor will deposit Rs. 90,000 + allied charges for the period of 06.05.2020 to 31. 05.2020 and necessary supplementary contract may be executed.
- 2. Once order is issued by MHA regarding unrestricted movement of persons & goods, full installment shall be deposited by the agency.
- 3. Office to collect periodic field data on different dates & for time till the next board meeting.

Board further resolved that necessary supplementary contract may be executed.

PCB and CEO were of opinion that as no amount has been deposited by the contractor for a period from  $22^{nd}$  March till 6<sup>th</sup> May, the loss to the board may be compensated by the contractor for this period.

CEO further brought to the notice of the board that based on the experience of this year certain conditions need to be amended for future viz. 1. amount of security deposit should be at least one months collection amount and 2.Instead of daily installments the amount should be deposited by the agency in advance in four installments on quarterly basis and 3. Condition of the solvency. CEO advised Board should finalize these conditions before start of next tender procedure.

A Note given by Smt. Manju Goel in this regard is recorded and pasted below:

# TO BE RESOLVED, NOTED AND PART OF MINUTES OF AGENDA ITEM NO. 11 BY WORD BY WORD AND STYLE.

I as a member disassociate with this agenda item with following comments.

There is no objection to the collection of vehicle entry fee as per the contract between the Cantonment Board and the contractor, moreover the matter is still sub-judice before the Hon'ble High Court, Allahabad in the matter of Writ Petition No 42817/2019 Smt. Anita Singh v/s Cantonment Board and 2 others and there is injunction of the Hon'ble High Court in favour of the petitioner, <u>As such the Board</u> <u>should not consider any undue request of the contractor causing huge financial loss to the Board.</u> He has all channels of redressal before the Court of Law. He should be advised to approach the court.

But it is surprising that under what hatched conspiracy, the contractor has been allowed to deposit Rs.50,000/- per day instead of contracted amount of Rs.4,21,750/- per day. I have strong objection to

the SELF-ASSESSED amount of RS. 50000/- per day being deposited in the account of Cantonment Board Meerut, on account of Vehicle Entry Fee w.e.f. 06.05.2020, instead of Rs. 421750/- plus allied charges per day despite Hon'ble High Court orders dated 20.12.2019,

Also the Contractors applications dated 12.02.2020 and 13.02.2020 stating that the contractor has not started Vehicle Entry Point at Delhi Road due to insufficient space cannot be considered as there is injunction by the Hon'ble High Court, Allahabad in Writ Petition No 42817/2019.

Further, the claim of expenditure due to stoppage of collection from 3 points of Rs. 33,63,681/- + Rs. 5,00,000/- (Court Expenses) = Total Claim Rs. 38,63,681/-, also cannot be considered as there is injunction by the Hon'ble High Court, Allahabad in Writ Petition No 42817/2019. The Contractor has all channels of redressal before the Court of Law. He should be advised to approach the court.

Further, Expenditure of Rs. 22,57,950/- incurred by the contractor for widening of roads etc is the matter of study of AGREEMENT and its Clause therefore this point should be pended for study.

The Member Secretary should see all this aspect but it is apparent that financial interests of the Board already under severe financial crisis is being compromised, this is a serious matter requires transparency and exposure of truth.

Also, CEO has no authority without Board approval, to deploy staff for survey of recovery per day from the Vehicle Entry Points by the contractor. It seems to appear that there is a well planned conspiracy to help the contractor by the office, at the financial cost of the Board.

The matter requires investigation. Moreover, it is also not understood WHY the contents of the survey report has not been kept confidential and surprisingly mentioned in the agenda item.

It is a serious issue and the Board Members cannot be make fool, responsibility should be fixed why the figures of survey been part of agenda, just to create a conspiracy or doubt in the eyes of members, I as a member disassociate with this agenda item, considering the past incidents of contempt of the Hon'ble High Court faced by the PCB and CEO.

Mobile Tower is necessity in the public interest as net connectivity in the cantt areas is very poor, therefore the amenity now cannot be stopped but the procedure adopted by the office of the cantonment board in commissioning of the towers was totally illegal and against the general norms of the contract viz recovery of the contractual amount on advance, thereafter execution of the contract agreement and in the last execution of the contract on ground, this has not been followed who is responsible, why even after earlier resolution dated 13.11.2019 of the Board, No action on the resolution has been taken and how the towers are (if) functioning without the payment of revenue and agreement. So it is suggested to follow general norms of contract and provide net connectivity through towers to the public as early as possible.
