## 318. <u>To revisit Agenda in CBR No. 317 dated 14.01.2020.</u>

Please refer to Hon'ble High Court of Allahabad order dated 20.12.2019 in Writ C-No- 42817 of 2019 titled as Anita Singh V/S Union of India & others (Annexure `A'). Said Agenda was circulated to note the order and review progress of Committee constituted vide CBR No. 285 dated 12.12.2019. Board while considering same on 14.01.2020, initiated the meeting 'in camera' and in the absence of any agenda discussed the issues involved in the case and deliberated in detail for 2 days i.e. 14.01.2020 & 15.01.2020 in contravention when Court had already passed an interim order of stay in earlier similar stand taken by Board. When matter is subjudice the board's action is overreaching mandate contained in Hon'ble High Court order dated 20.12.2019.

It was ordered by the Hon'ble High Court that until further orders of the Court, the effect and operation of the order dated 15.01.2020 shall remain stayed vide an order dated 23.01.2020 passed in Writ No. 2168 of 2020 Smt. Anita Singh v/s Union of India & 04 others (Annexure 'B'). PCB & CEO appeared in person on 27.01.2020. On 27.01.2020, President Cantt Board submitted his personal affidavit and C.E.O showed the documents to Hon'ble Court. Subsequent order of Hon'ble High Court dated 27.01.2020 is appended herewith (Annexure 'C').

"Considering the facts and circumstances of the case, instead of taking any further action in the matter, in the interest of justice, we are adjourning this case to be placed again on Board on 03.02.2020 and hope and trust that the respondent authorities who are present in person before this Court shall take appropriate measure to mend their ways and file an affidavit to that count."

In the light of Hon'ble High Court order in Writ No. C-42817 of 2019 Anita Singh V/S UOI & others, impending stay, the board should revisit the resolution dated 15.01.2020 and consequential order passed by the Chief Executive Officer, and take suitable decision in the matter.
